# MISSION STATEMENT

The principal mission of the Chemung County Sheriff's Office is to preserve the rights of citizens and reduce fear in the community through the prevention of crime, protection of persons, property and maintenance of order in public places and anticipate and respond to events that threaten public order and the protection of life and property.

It is essential all personnel remember that in the execution of their duties they act not for themselves but for the good of the public. They shall respect and protect the rights of individuals and perform their services with honesty, zeal, courage, discretion, fidelity and sound judgment.

Deputies must seek and preserve public confidence by demonstrating impartial service to law and by offering service and trust to all members of the public.

It is the expressed policy of this Agency that Deputies will use force only when the exercise of persuasion, advice and warning is found to be insufficient to obtain public cooperation to an extent necessary to secure observance of law or to restore order and to use only the minimum degree of physical force which is necessary upon any particular occasion for achieving a police objective.

The Chemung County Sheriff's Office is a New York State Department of Criminal Justice Services accredited agency. The Sheriff's Office has held this status since 2010. As of 2024, there are over 165 agencies located all over the state that are currently accredited, ranging in size from a small handful of full-time officers to more than 4,000 sworn personnel. Insurance benefits, enhanced community support, and a greater overall standard of professionalism are just a few of the many tangible benefits that accredited agencies enjoy.

The positive impact of the Accreditation Program stems from the profound commitment that New York's law enforcement executives have made to excellence and professionalism in the field of law enforcement, and from their desire to provide the best possible services to the communities that they serve. The Accreditation Program continues to provide a comprehensive blueprint for effective, professional law enforcement, (New York State Division of Criminal Justice Services).

#### From the Sheriff:

The Office of the Sheriff is known as the "Peoples Law Enforcement". This is, in part, because the Sheriff is elected by the people. Sheriff's Offices are responsible for conducting law enforcement duties in the rural parts of the county, as well as running and maintaining a full-time correctional facility and E911 Communication Center. Sheriff's Deputies have jurisdiction in the entire county, which consists of 412 square miles. While Sheriff's Deputies frequently and routinely provide back-up to other agencies within the county, their main duties and responsibilities fall to the citizens who live in the rural parts of the county, who at times don't see a police presence. These create many unique challenges to the Deputy that they must adapt to daily. These challenges include, but aren't limited to, dealing with armed suspects, vehicle pursuits, mental health persons, individuals under the influence of drugs and/or alcohol, domestic cases, executing warrants, conducting vehicle stops, and etc.

Equally challenging, is the correctional facility, which houses a maximum of 262 Incarcerated Individuals (II's) (both male and female). These IIs are incarcerated for a variety of charges, ranging from minor Misdemeanors to violent Felonies. Some IIs are housed for periods of time up to, and in some cases, exceeding one-year. Our II population provides a variety of challenges such as violent behavior, disciplinary problems, medical issues, pregnant females, escape attempts, assaults on staff, suicides, mental health and detoxing individuals, to mention a few.

In 2022, we added the E911 Center as the fifth division of the Chemung County Sheriff's Office. The men and women of this division remain our unseen heroes. They are responsible for receiving nearly 200,000 calls annually! Ninety percent of those calls are law enforcement related, but also include calls for medical or fire services as well as other miscellaneous requests. This does not include any outgoing calls they have to make in the course of their shift. In addition, each dispatcher goes through extensive training to include typing, emergency medical dispatch, communication, etc. prior to being allowed to dispatch on their own.

Each year presents new innovations or ideas and certainly new challenges. As your Sheriff, I look forward to these many challenges that we face as an agency and a community. I am proud to be the Sheriff of this county and especially proud to be a member of an agency that has such deep roots within the history of our county. In 2024, the Chemung County Sheriff's Office, and all men and women of law enforcement, were faced with challenging times, but also found many successes.

#### 2024 Accomplishments:

The Chemung County Sheriff's Office had a busy 2024. Many goals and objectives had been put in place for the 2024 year, which we were able to achieve. These goals and objectives included:

- 1. We were able to successfully fully staff our E911 Communication Center.
- 2. We were successful in our continuing efforts in updating and improving the effectiveness of our E911 Communication Center. We accomplished this by integrating the use of the Elmira Police Department Flock camera system, which works to alert Communication Center Operators when the gunshot detection system is activated. This allows for quick dispatching of law enforcement to the area where the gunshot(s) are detected.
- 3. We were successful in upgrading our Body Cameras for jail personnel which provides better audio and video quality for interactions with IIs.
- 4. We were successful in the launch of our new Sheriff's App. With 5,000+ downloads, the App serves as an innovative way for the Sheriff's Office to connect with Chemung County residents and visitors, providing information quickly & efficiently to anyone with a smartphone.
- 5. We started to work on a multi-county radio project, which is slated to be completed by 2027. This will upgrade our radio system and provide redundancy with the radio capabilities for law enforcement, fire, and county highway personnel.

#### Moving forward:

The Chemung County Sheriff's Office is committed to maintaining our achieved accomplishments and agency professionalism throughout the year. We will work hard to achieve this with goals and objectives set in place for 2025. These include, but aren't limited to, the following:

- 1. Purchasing and implementing a full person body scanner for Incarcerated Individuals in an effort to assist with identifying and eliminating contraband in the facility.
- 2. We will continue the work on the multi-county radio project in an effort to keep our timeline on track for the 2027 completion date.

- 3. Continue to work hard to get all divisions of the Sheriff's Office to full staff and to retain personnel in order to provide the best service possible to the community.
- 4. We will be looking to complete our reaccreditation process for the Road Patrol Division.
- 5. We hope to implement a new Commissary process for the Chemung County Jail through the Keefe Group, who will facilitate this process for all Incarcerated Individuals.
- 6. We are budgeted to upgrade the Chemung County Jail with all new video and surveillance equipment as a major security benefit to all personnel, Incarcerated Individuals, and civilian staff who conduct various duties and responsibilities throughout the year.

In closing, I wish to thank the men and women of the Chemung County Sheriff's Office for their continued hard-work, dedication, and professionalism to the community in which they serve. I would also like to thank the community for their support of our efforts to achieve our goals at the Sheriff's Office to better serve them.

# **Patrol Services Division**

The Chemung County Sheriff's Office Patrol Services Division consists of three 8 hour shifts, which provides 24 hour/365 days a year of law enforcement coverage to the citizens of Chemung County. The Road Patrol is an Accredited Agency through the New York State Division of Criminal Justice Services. The Patrol Services Division is the most visible division of the Sheriff's Office and it is overseen by the Road Patrol Captain. The Road Patrol handles calls for service throughout the county and they enforce all laws anywhere within Chemung County. The Patrol Services Division embraces the Mission Statement of the Sheriff's Office; "To preserve the rights of citizens and reduce fear in the community through the prevention of crime, protection of persons, property and maintenance of order in public places and anticipate and respond to events that threaten public order and the protection of life and property."



# Patrol Services Division

## Patrol Staff

The Patrol Services Division is supervised by the Patrol Services Captain, who is responsible for the day to day operations of the Patrol Division, to include scheduling, monitoring of overtime, adherence to the Policy and Procedure, and investigating complaints against Deputy Sheriffs. Under the Captain are three Lieutenants, who run the day to day operation of their respective shifts, and three Sergeants who assist the shift Lieutenant with supervising Deputy Sheriffs assigned to their shift.

# **Patrol Activities**

The Patrol Services Division responds to calls for service, investigates crimes against persons and property, and aides other government agencies with their duties. During the year 2024, the Patrol Services Division recorded 22,796 primary complaints. The Patrol Services Division issued 2,681 traffic tickets to motorists over the year and investigated 581 reportable motor vehicle collisions.







# **Patrol Services Division**



## **Enhanced Patrol Activities**

The Patrol Services Division participates in several New York State Governor's Traffic Safety Grants: Police Traffic Services Grant and Buckle Up New York, and DWI Crackdown Enforcement Grant. The traffic safety grants run through the state's fiscal year of October 1st through September 30th.

This year the Traffic Safety Grant provided funding for 98 hours of dedicated traffic enforcement, issuing 118 Traffic Tickets. These dedicated enforcement efforts are targeted at aggressive driving with the goal of reducing traffic collisions.

#### **DRE**

Deputy Jacob Cardinale is a Certified Drug Recognition Expert (DRE) who is highly skilled in the detection and identification of persons impaired by alcohol and/or drugs. He is trained to conduct a systematic and standardized 12-step evaluation consisting of physical, mental and medical components. Deputy Cardinale completed three phases of classes with over 70 hours of training.



# **Patrol Services Division**

## **Highway Safety**

The Sheriff's Office performs an active role with traffic enforcement on Interstate 86, the major Interstate that runs through Chemung County. The Sheriff's Office participates in the New York State Governor's Traffic Safety Committee Police Traffic Services Grant, for dedicated traffic enforcement details. This allowed the Sheriff's Office to maintain an enforcement presence on Interstate 86 in addition to maintaining a police presence in the community.



#### Naloxone-Narcan

In July of 2014, the Chemung County Sheriff's Office was trained and began carrying Naloxone (NARCAN). Naloxone is a pure opiate antagonist and prevents or reverses the effects of opioids including respiratory depression, sedation and hypotension and reverses the effects of other narcotic medicines, such as the illegal use of an opioid substance, like heroin. Since the implementation of Naloxone, the Chemung County Sheriff's Office successfully administered it on over 127 citizens that had overdosed on heroin or opioid derivative which resulted in their lives being saved. In 2024, the Chemung County Sheriff's Office has successfully administered Narcan in the following jurisdictions:

# K-9 Unit - Egon





K-9 Egon is a Malinois purchased by the CCSO in 2020 and he has been working with his handler, Sgt.
Pirozzolo since then. He is certified by NYS DCJS as a Patrol, Tracking and Narcotics K-9 and assists in lost and missing persons, combating the flow of dangerous drugs in our area, and aids in the tracking and apprehension of suspects.



# Bike Patrol

The Sheriff's Office and other local law enforcement agencies have participated in bike patrols at various locations/events throughout the county, to include the Lackawanna Catherine Valley bike and hiking trail. While patrolling these areas, personnel are interacting with the public on a variety of levels to include looking for and apprehending subjects with outstanding Warrants.






# Special Services Unit



The Special Services Unit (SSU) consists of 10 members of the Sheriff's Office. The SSU team receives 192 hours of training each year to include training on firearms proficiency, physical fitness, search warrant executions, tubular vehicle assaults, methodical searching techniques and room clearing, as well as violent felony warrant arrests. 

# HIGH PROFILE CID CASE OF 2024 MASSALINE & HALEY

On March 29, 2024, CCSO and NYSP conducted a joint retail theft detail at the Target store in Consumer Square. At about 6:45 p.m., while pursuing a larceny suspect in the parking lot on foot, the suspect ran toward a get-away car and attempted to jump over the hood. Inv. Theetge was directly behind the suspect and was able to tackle him on the hood of the vehicle. Instead of stopping, the driver accelerated the vehicle and turned abruptly causing Inv. Theetge and the suspect to fall off the hood. The suspect landed directly on top of Inv. Theetge causing Inv. Theetge to strike his head on the pavement, rendering him unresponsive. As a result of the driver's actions, Inv. Theetge sustained a skull fracture and brain bleed. All feared Inv. Theetge would not survive his injuries. Due to his strong will to live, the love and support of his family and friends, his family in blue, as well as the outpouring of support and contributions from the community, Inv. Theetge is well on his way to a normal life again. During this incident, a NYSP Investigator, Brian Kozemko, was also injured while taking the larceny suspect into custody. The Sheriff personally wants to thank all law enforcement, E911, and all medical personnel for everything they did that night and in the weeks to follow.

The larceny suspect, **DOMINICK J. HALEY**, age 24, was taken into custody immediately. HALEY was charged with Assaulting a Police Officer and Assault in the 2<sup>nd</sup> Degree, both class C Violent Felonies, and Petit Larceny, a Class A Misdemeanor. On 03/03/25, HALEY plead guilty to all charges. He was sentenced to 12.5 years in prison and 5 years post-release supervision.

A massive law enforcement search was conducted for the driver, **FATIUNAA**. **MASSALINE**, age 24, who eventually turned herself in the next day. MASSALINE went to trial and was found guilty on both charges, Assaulting a Police Officer and Assault in the 2nd Degree, both Class C Violent Felonies. She was sentenced to 12.5

years in prison and 5 years post-release supervision.



















# HIGH PROFILE CID CASE OF 2024 WILLIAMS HOMICIDE

On November 15, 2024, at about 12:46 a.m., Sheriff's Deputies were dispatched to 1154 Richard St., in the Town of Southport, to investigate a report of a shooting that occurred at that location. Upon arrival, Deputies learned that there was a birthday party at that location consisting of mostly underage people. At some point in time, the victim, J'SEAN WILLIAMS, age 21, went outside the residence and was shot multiple times by an individual(s) who then fled the area in a vehicle. Shortly thereafter, J'SEAN WILLIAMS died as a result of the injuries he sustained. The Sheriff's Office spent many man hours working on this case, which resulted in the arrest of MICHAEL WILLIAMS, age 17, on 11/23/24. He was charged with Murder in the 2nd Degree, a Class A-1 Felony, and Criminal Possession of a Weapon in the 2nd Degree, Class C Felony. Disposition is still pending.

The Civil Division is an accredited division through the NYS Sheriff's Association for meeting or exceeding more than 120 standards set forth to earn this recognition. In 2024, the Civil Office processed \$1,054,226.20 in monies received. The majority of the revenue was the result of money received from wage garnishments in the form of income executions, which are received from attorneys and private individuals for the purpose of debt collection. This resulted in poundage of \$110,894.26, which was transferred to the Chemung County Treasurer's Office. The Civil Office consists of one Lieutenant, one Sergeant, one Deputy, and one full-time Clerk.

## **Records Division**

The Records Division is a central data collection and processing office responsible for compiling and processing case files, arrests and accident reports. In addition, this office is responsible for completing audits, reports and FOIL requests. The office is vital to the Deputy Sheriffs as it reduces their administrative workload and enables the Deputies to concentrate their efforts on patrol functions. The office received 523 FOIL requests, completed 290 background checks and processed 390 warrants. The office also provides statistical data to both State and Federal agencies. The Records Office is also responsible for arranging juvenile transports for the Chemung County Family Court and in 2024, 72 transports were completed. The Records Office consists of one full-time clerk.

#### Pistol Permit Division

In 2024, the Pistol Permit Office issued 173 new permits and processed 1,432 amendments, which included handgun purchases and transfers. There were 47 pistol permits that were suspended or revoked and 6 applicants who were denied. The total revenue generated by the Pistol Permit Office in 2024 was \$38,383.00, which includes new applications, amendments and purchase coupons. The Pistol Permit Office consists of one full-time clerk.

## **Airport Security**

The Sheriff continued to support the Elmira/Corning Regional Airport in 2024 by providing on-site law enforcement coverage at the airport. This assignment is a deterrent to terrorism while supporting the public interests of the passengers and guests.





## The Human Resource Center Security

The Human Resource Center Security consists of two full-time Deputy Sheriffs. Their duties include maintaining security, supporting staff and screening the civilians entering the building. These Deputies were also assigned to completing Sheriff's Office background checks and enter-ing court depositions into Flex, the records management system. In 2024, there were 109,392 persons scanned at the entry checkpoint. There were 720 restricted items identified during initial screening process and prohibited from entering the facility.

For the 2023 -2024 school year there were four (4) School Resource Officers, and sixteen (16) Special Patrol Officers assigned to local schools, which represented the Elmira City School District, BOCES Campus, Finn Academy, and the Horseheads School District. In addition, there are two (2) supervisors assigned to oversee personnel within each of these schools who are responsible for coordinating training, scheduling, special event coverage, acting as a liaison with school administration to name a few of their many duties and responsibilities. The breakdown of the assignments of personnel is as follows; there is one (1) School Resource Officer assigned to each of the following schools: Elmira High School, Broadway Academy, Ernie Davis Academy, and the BOCES campus. There is one (1) Special Patrol Officer assigned to each of the following schools: Pine City, Broadway, Parley-Colburn, Riverside, Diven, Hendy, Fassett, and Beecher Elementary. There is also a Special Patrol Officer assigned to Finn Academy and the BOCES campus. These School Resource Officers and Special Patrol Officers have been instrumental in providing the schools, staff and students with a law enforcement presence that assists in maintaining order and a safe learning environment.

In addition, the Chemung County Sheriff's Office has six (6) Special Patrol Officers assigned to the Horseheads School District. These Special Patrol Officers are assigned to Big Flats, Gardner Road, Center Street, and Ridge Road Elementary schools, the Middle/Intermediate School, and the High School.

In this environment, and in addition to their regular duties and responsibilities, the School Resource Officers/Special Patrol Officers were also required to enforce the New York State Penal Law and the New York State Family Court Act which resulted in, 6 felony, 25 misdemeanor and 10 violation arrests. Fortunately, arrests within the schools are not a common occurrence as the focus remains on creating a safe and orderly learning environment for all.







Southport Residential Deputy Joshua Arnold

The Sheriff maintained his support to the Town of Southport in 2024 by providing one full-time Deputy Sheriff to the Town of Southport, for the purpose of additional law enforcement coverage. In this partnership with the town, the Sheriff has provided the town with an additional patrol at a reduced cost to the taxpayers. The Residential Deputy completed 734 calls for service, completed 26 arrests, and issued 139 traffic tickets. The Southport Resident Deputy completed over 13,000 miles of patrol activities in the Town of Southport for 2024.

#### **Incarcerated Individual Education Services**

The facility must offer educational services to all Incarcerated Individuals who are under the age of 21 and have yet to receive their High School Diploma or TASC Diploma. The facility also offers Incarcerated Individuals who are over the age of 20 the opportunity to get their TASC diploma if they have yet to receive their High School Diploma or TASC Diploma. Due to the facility no longer housing 16 and 17-year-old Incarcerated Individuals, the facility continues to offer school for those who qualify and are looking to receive a TASC diploma. Diploma testing can no longer be done in the facility due to NYS guidelines. We continue to offer Incarcerated Individuals wishing to study and pre-pare for testing that opportunity.


# Total E911 Phone Volume 2023 vs. 2024


# Percentage of Calls by Jurisdiction for 2024



The Sheriff's Office participated in various Community Outreach events to include Town Hall meetings and Community related events in an effort to engage the community. These events afforded the community the opportunity to voice their concerns relating to issues in their respective communities as well as allowing the Sheriff's Office to formulate plans to address these concerns. This has led to an increased focus on community policing, especially in rural areas.

# Special Enforcement Details

Sixteen (16) enforcement details were conducted to include drug and illegal weapons interdiction. Increased utilization of hotels by criminals in an effort to avoid detection has prompted a focus on enforcement at these locations. The Sheriff's Office has offered assistance in an effort to reverse this trend. Several of these details involved the various police departments in the area working collaboratively. Examples of multi-agency details were Gun Initiative Violence Elimination (GIVE) details, retail area and hotel enforcement details, Operation Take Back the Streets, and retail theft enforcement details. The Sheriff's Office hosted four (4) trainings for area Law Enforcement, to include DCJS Firearms Instructor Refresher Course, AR-15 Armorers Course, Drug Identification Training and Interview and Interrogation Training.

## **Community Presentations**

The Sheriff's Office conducted over 22 presentations to the community in 2024, some of these include Active Shooter (4), Threat Assessments (7) and Home Visit Safety (1).

#### HR218

HR 218, is known as the "Law Enforcement Officers Safety Act", which was signed into law on July 22, 2004 by then President George W. Bush and exempts qualified active and retired law enforcement officers from local and state prohibitions on the carrying of concealed firearms. Both the "qualified active law enforcement officer" and "qualified retired law enforcement officer" must meet the definition of just that outlined in the bill. The Chemung County Sheriff's Office holds HR 218 firearms qualification for qualified retired law enforcement officers twice annually. The qualification is held at the Sheriff Charles D.W. Houper training facility located in Breesport. The average class size per training is generally twenty retired law enforcement officers who are from the Chemung County Sheriff's Office, Elmira City Police Dept., Horseheads Police Dept., Elmira Heights Police Dept., New York State Police and New York State Corrections. In 2024, the Sheriff's Office certified 42 qualified retired law enforcement officers.

# Arctic League



Again in 2024, Arctic League volunteers delivered gifts to thousands of children in Chemung County on Christmas Eve!



# Pharmaceutical Medication Drop-Off Program

Since 2010 the Chemung County Sheriff's Office has participated in the National Take-Back initiative in conjunction with the DEA. Each year the events have netted significant results in collecting expired and unused medications that otherwise would be disposed of improperly or possibly stolen. Since 2010, we have collected 22,090 lbs of medication from 7,697 people.





On both Saturday April 27, 2024 & October 26, 2024 the Chemung County Sheriff's Office hosted two drop-off sites in Chemung County. In 2024, we collected 1,651 pounds of medications from 460 people.

## Shop With A Cop



"Shop with a Cop" is a national community policing program that has been in existence for over two decades. It has long been noted that relationships between law enforcement and their respective communities have been very strained, especially in today's society. The initial intent of the "Shop with a Cop" program was to be utilized as a community policing function to assist and address the issues of repairing these strained relationships. One methodology of community policing is to build positive relationships with the younger kids, ages 5 and up, within the communities. The effects of the program are multi-faceted and indispensable. "Shop with a Cop" hopes to break down the barriers between the communities, in which we as police serve, with the intent of developing a better and more trusting relationship, beginning with our youth.







# Community Outreach Operation Safe Child

The Chemung County Sheriff's Office participates in the SAFE CHILD Card program, which is a free public service administered by the New York State Sheriffs' Association, Inc. Using equipment that contains the latest digital fingerprinting technology and high-resolution photography capabilities, 58 County Sheriffs and other law enforcement agencies are able to produce a SAFE CHILD Card for parents or guardians. The goal of this program is to provide parents and children with important child safety information and to capture the fingerprints, basic biographical information, and photographs of children – information critical to expediting the return of a missing child. In addition to being able to quickly provide important details to law enforcement agencies investigating a child's disappearance, the NYSSA SAFE CHILD Card will serve as an important tool when used in conjunction with the NYS AMBER Alert and Missing Child Alert programs. The card contains a child's name, biographical information (including date of birth, gender, height, weight, hair color, eye color, and other identifying data), and a fingerprint image of both index fingers. The card can be made in less than two minutes and can be easily carried in a wallet or purse.






